

STUDENTS of all ages, interests and levels of experience learned and explored their creativity with the guidance of Bray artists.






Benefit Auction

Not only did the Bray galleries give the resident artists an opportunity to show and sell their work. but they gave those who are passionate about ceramics an opportunity to purchase and bring world-class artwork into their homes and daily lives.

EDUCATION

Bray resident artists shared their knowledge through the Community Classes, enabling children and adults to explore all aspects of working with clay. While some learned basic skills, others enrolled in advanced, special-topics courses covering everything from mono-printing on clay to glaze exploration

Moreover, artists and students from around the country traveled to Helena for a series of intensive workshops. These courses, taught by our visiting artists, offered inspiration and motivation from leaders in the field.


